Transfer:

You can apply to transfer into the BA/LLB after your first year of tertiary study. You will be assessed on either your tertiary or secondary grades, whichever is higher. If you have not studied at tertiary level for at least one year full-time in the same degree, you will be assessed according to your secondary qualifications only. If you are unsuccessful in a transfer application at the end of the first year you can reapply after the second year. The credit transfer policies of the Law School and its partner faculties are used when determining the amount of credit for previous studies. However, it is not possible to complete Combined Law within five years if you transfer after more than one year of university study.

For the Bachelor of Commerce component, you must complete all junior core Commerce units within your first year of study with *BUS1000 Future of Business* completed in your first semester. The senior core unit, *BUS2000 Leading and Influencing in Business*, must be completed in your second year of study.

Candidates in a Combined Law program must successfully complete *LAW1006 Foundations of Law* before enrolling in any other Bachelor of Laws (LLB) units of study. Applying for honours

In some of the more specialised careers open to Bachelor of Commerce graduates, employers may be looking for a level of specialisation that is not provided by a pass degree. Similarly, if a student wishes to qualify for specialised postgraduate research study, a pass degree is not normally sufficient. Honours considerably enhances a qualification and singles students out to an employer as having exceptional ability

The Bachelor of Commerce and Bachelor of Advanced Studies with honours provides knowledge and training for candidates in research methods as well as experience in planning, performing and writing up research under the guidance of a supervisor. It involves a combination of coursework and research toward the writing of a short thesis.

In the Bachelor of Commerce and Bachelor of Advanced Studies, students would complete honours as their fourth year of study.

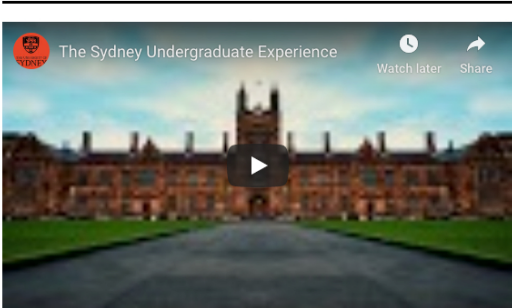

Upon completion of your engineering units, you will complete the remaining nine law core units in your fifth and sixth year as well as seven electives which will allow you to specialise in a particular area of the law.

This course includes mandatory completion of the **Professional Engagement Program (PEP)**. The program requires completion of 600 hours of professional engagement experiences integrated continuously throughout the first four years of the degree. It is designed to allow students to contextualise their learning, enhance their own professional development, and build the foundations of a strong professional engineering career. The professional engagement activities are spread over 3 flexible stages. This involves

- a minimum of 70 hours of non-engineering focused activities (casual or part-time work, volunteering, employment skills, mentoring and/or development of transferable skills) and
- a minimum of 200 hours of engineering focused activities (industry projects, site visits, guest lectures, interviews, seminars, conferences and/or research)
